# **HPO COVID-19 Response and Updates**

Data continue to show the importance of vaccination and booster doses to protect

individuals both from infection and severe outcomes of COVID-19. The CDC has provided <u>updated</u> <u>guidance</u> that allows a second booster of the COVID-19 vaccine to be administered at least 4 months after a first booster for those who fit any of the following criteria:

- Individuals at least 50 years of age
- Individuals with immune compromise
- Individuals of any age who received the Johnson & Johnson COVID-19 shot for their initial vaccine and booster dose



# **HPO Staff Spotlight: Matthew Stimmel, PhD**



As National Training Director, Matthew Stimmel is responsible for developing and sustaining the education and training of more than 400 Veterans Justice Program (VJP) field staff – but his role often surpasses these expectations. Stimmel is critical to a number of programs and initiatives throughout HPO, including co-leading the Racial Equity and Racial Justice Workgroup, providing educational curriculums to

support the development of innovative practices across homeless programs, and offering training content for partners.

Stimmel has a strong understanding of the criminal justice system and the related cycle Veterans can find themselves in, believing strongly that these Veterans deserve support rather than punishment – and that like all Veterans, they deserve access to the care they earned while serving our country.

## **HPO Fact of the Month**

Did you know that VA can pay certain benefits to Veterans who are incarcerated in a Federal, State, or local penal institution?

It's important that justice-involved Veterans are familiar with VA benefits, including which ones they may still be eligible to receive. The amount VA can pay depends on the type of benefit and reason for incarceration.
