- Subj. Class Deviation from VA Acquisition Regulation Parts 803, 819, 827, 847 and 849
  Regarding Certified Mail Receipt Requested and Mail Requirements (VIEWS 02946850)
- To: Heads of the Contracting Activities
  - **1. Purpose.** To issue a VA Acquisition Regulation (VAAR) class deviation in accordance with FAR 1.404, Class deviations, to provide an exception to certified mail receipt requested and mail requirements.
  - 2. Effective Date. October 1, 2020.
  - **3. Expiration Date.** This deviation expires once incorporated into the VAAR or is otherwise rescinded.
  - **4. Applicability.** These class deviations apply to all VA contracting activities.
  - **5. Current VAAR Policy:** Various Federal Acquisition Regulation parts require certified mail receipt requested or mailing, without the flexibility of other methods for such mailing or obtaining evidence of receipt, such as electronic return receipt.
  - **6. Need for Deviation.** Flexibility to allow other methods of mailing and evidence of receipt for notices and documents will be beneficial during times of emergency or crisis, such as those presented by the Novel Coronavirus 2019 pandemic.
  - **7. Required Action.** Contracting officers shall follow the procedures described in the attached VAAR deviations.
