### Part I: Summary of ACFPOW 2020 Recommendations

**Recommendation #1**: Office of Enterprise Integration (OEI): The Department of Veterans Affairs, National Center for Veterans Analysis and Statistics (NCVAS), shall update the NCVAS Pocket Card with the "Estimated Number of American Former Prisoners of War," as of 9/30/2020, by the end of the third quarter of FY 2021, and subsequently update this information on an annual basis.

<u>Recommendation #2</u>: The National Cemetery Administration (NCA): The Department of Veterans Affairs, National Cemetery Administration shall add a specific checkbox termed "POW" in an appropriate placement on VA Form 40-1330 for future inscriptions, and include a POW headstone or marker in the illustrations, when the form is updated subsequent to its December 31, 2020, expiration.

**Recommendation #3:** Veterans Benefits Administration (VBA): The Department of Veterans Affairs, Veterans Benefits Administration shall develop an accurate demographic review of living Former Prisoners of War through collaboration with other departments (e.g., the Department of Defense, the Social Security Administration, etc.), which results in listing/count of living American Former Prisoners of War (FPOW) as of 9/30/2020. The review to be provided by the end of the first quarter of FY 2021.

## Part II: ACFPOW 2020 Recommendations, VA Responses and 2020 Action Plan Templates

<u>Committee Recommended Action 1</u>: The Department of Veterans Affairs, National Center for Veterans Analysis and Statistics (NCVAS), shall update the NCVAS Pocket Card with the "Estimated Number of American Former Prisoners of War," as of 9/30/2020, by the end of the third quarter of FY 2021, and subsequently, update this information on an annual basis.

VA Response: Concur.

OEI, NCVAS, is collaborating with VBA to acquire this information for incorporation into the NCVAS Pocket Card during fiscal year (FY) 2021.

<u>Committee Recommended Action 2</u>: The Department of Veterans Affairs, National Cemetery Administration shall add a specific checkbox termed "POW" in an appropriate placement on VA Form 40-1330 for future inscriptions, and include a POW headstone or marker in the illustrations when the form is updated subsequent to its December 31, 2020, expiration.

VA Response: Concur in principle.

NCA will add a box for POW and EX-POW to include adding a photograph of a marker showing an inscription of either POW or EX-POW to VA Form 40-1330, *Claim for Standard Government Headstone or Marker* with these changes will be completed no later than December 2021 due to the process and approval procedures for updating. The current VA Form 40-1330 will remain valid until this update has been completed.

#### **VA Response:** Concur in principle.

VBA will work with the Department of Defense (DoD) and Social Security Administration (SSA) to obtain a listing/count of living American Former Prisoners of War by the end of the first quarter of FY 2021. We concur in principle that VBA can only provide an account based on the FPOW within the VA system and data received from collaborating Federal agencies.
