Introduction

The MH FLOW Discharge template content is being added as an option to both the MHTC BHIP CC ASSIGNMENT and MTHC BHIP CC NEEDS ASSESSMENT AND INTERVENTION to help streamline documentation for Veterans who are ready to step down care to Primary Care or to graduate from mental health care.

Currently, both an unassignment note and a FLOW discharge note would be required to discharge a Veteran from the BHIP program.

With the addition of the MH FLOW Discharge note into the MHTC BHIP CC ASSIGNMENT and MTHC BHIP CC NEEDS ASSESSMENT AND INTERVENTION the MHTC Care Coordinator has the option to complete both of these actions in one note.

No changes to the existing content of either template were made.

Post Installation

1. Insert local objects into the dialog text.

a. Using the pre-install inquiry, replace the text “INSERT OBJECT HERE” with your local objects for Primary care Provider and PACT Team. In VistA, Reminder Dialog Management, Reminder Dialogs, change view to Group, search list and navigate to reminder dialog group **VAL-GP MH DISCHARGE NEXT PCP**, and edit the group header dialog text.

b. Using the pre-install inquiry, replace the text “**INSERT PATIENT ADDRESS OBJECT**” with your local object. In VistA, Reminder Dialog Management, Reminder Dialogs, change view to Elements, search list and navigate to reminder dialog element **VAL-MHTC VVC HOME ADDRESS**, and edit the dialog text.

2. Using the pre-install inquiry, replace the text “**INSERT PATIENT PHONE OBJECT**” with your local object. In VistA, Reminder Dialog Management, Reminder Dialogs, change view to Elements, search list and navigate to reminder dialog element **VAL-MHTC VVC PHONE**, and edit the dialog text.

3. In CPRS, open the note titled MHTC BHIP CC ASSIGNMENT (reminder dialog VA-MH TREATMENT COORDINATOR ASSIGNMENT) and confirm the version number is 2.0.

4. In CPRS, open the note titled MHTC BHIP CC NEEDS ASSESSMENT AND INTERVENTION PLAN (reminder dialog VA-MHTC CARE COORDINATION INTERVENTION) and confirm the version number is 4.0.

5. Add local finding to the following elements as applicable for your site:
Using the VistA menu reminder Dialog manager, Reminder Dialogs, change your view to element view.

a. VA-MHTC SRR ECONSULT TODAY - add local suicide risk flag e-consult order

b. VA-MHTC REFERRALS SUBMIT TODAY - add mh consult menu

c. VA-MHTC REFERRALS PEER TODAY – add consult for peer support services
