Introduction

As per 38CFR Part 17 RIN 2900-AR57 the Veteran's Health Administration has amended its medical regulations to:

- 1. Remove the exclusion on abortion counseling.
- 2. Establish exceptions to the exclusion on abortions for Veterans who receive care at the VA and CHAMPVA (Civilian Health and Medical Program of the Department of Veterans Affairs) beneficiaries.

This new documentation template was created to support this change.

Users of the template will be those who provide treatment for early pregnancy loss or abortion, using medication or a procedure, including those who are referring patients to the community for that care.

Install Example

Go to Reminder exchange in Vista. To Load the exchange file, use LWH. The URL is https://REDACTED /UPDATE_2_0_403.PRD



You will see a message indicating the file was loaded successfully.

Search and locate an entry titled UPDATE_2_0_403 VA-WH PREGNANCY LOSS OR ABORTION in reminder exchange.



At the <u>Select Action</u> prompt, enter <u>IFE</u> for Install Exchange File Entry Enter the number that corresponds with your entry titled UPDATE_2_0_403 VA-WH PREGNANCY LOSS OR ABORTION *(in this example it is entry 621, it will vary by site)* that is dated 11/22/2023.

- 3 Service SRV [choose from SERVICE/SECTION]
- 4 Division DIV [SALT LAKE CITY]
- 5 System SYS [NATREM.FO-SLC.MED.VA.GOV]

When you type a question mark above, you will see the list of #'s (with dialogs) that are already taken. Choose a number **NOT** on this list. For this example, 390 is not present so I will use 390.

2. Add the template to your shared template folder. This template is designed to be incorporated into any provider or nurse note (note title may vary site to site). It should be added to the shared template folder so that it can be incorporated into an existing note by the user.

In CPRS, open the Template Editor, expand Shared Templates, select the appropriate folder (if applicable), then click New Template (top right-hand corner).



Type in the following information: Name: **PREGNANCY LOSS OR ABORTION** Template Type: **Reminder Dialog** Reminder Dialog: **VA-WH PREGNANCY LOSS OR ABORTION** — then click Apply.

3. Add quick orders to the dialog. Using the VistA menu Reminder Dialog Manager, Dialog Manager, change view to elements, search for and edit the following elements, you will add your quick order as **a finding item**:

- VA-WH PREGNANCY GEST AGE UNKNOWN ORDER ULTRASOUND add your local quick order for transvaginal ultrasound.
- VA-WH PREGNANCY GEST AGE UNKNOWN ORDER ULTRASOUND ABORTION add your local quick order for transvaginal ultrasound.
- VA-WH PREGNANCY TERM ADD ORDER CONTRACEPTION add your local quick order for emergency contraception.
- VA-WH PREGNANCY TERM ADD ORDER SOCIAL WORK add your local quick order for social work consult or referral.

- VA-WH PREGNANCY TERM ADD ORDER MH CONSULT add your local quick order for a mental health consult or referral
- VA-WH PREGNANCY TERM ADD ORDER RTC add your local return to clinic order
- VA-WH PREGNANCY LOSS PLAN REFER add your local community care consult for pregnancy loss.
- VA-WH PREGNANCY TERM PLAN REFER- add your local community care consult for abortion.
- VA-GP WH PREGNANCY LOSS PLAN MED MANAGE add your local quick order or menu for pregnancy loss medications (Mifepristone and Misoprostol).
- VA-GP WH PREGNANCY TERM PLAN MED ABORTION add your local quick order or menu for pregnancy loss medications (Mifepristone and Misoprostol)

4. Add additional local follow up items to the plan section (OPTIONAL). Using the VistA menu Reminder Dialog Manager, Dialog Manager, change view to group, search for and edit the following groups, you can add locally created elements to the items available in the follow up portion of the plan sections by adding your local elements or groups at the sequence prompt. The groups listed are a class of local and can be locally modified. Consult your local Women's Health providers to see if they would like any additional items added. Your site may choose to not make any edits to these sections:

- VAL-GP WH PREGNANCY TERM PLAN FOLLOW UP
- VAL-GP PREGNANCY LOSS PLAN FOLLOWUP
